- The Exhibitor agrees to pay the sum above specified as follows: 50% due upon the execution of this agreement, and the remaining balance due by 60 days prior to the event. For all credit card payments, any balance due other than deposit will be automatically charged to the card on file 60 days prior to the event. Exhibitor agrees to all credit card processing fees.
- The actual occupation of the space is of the essence hereof. - Exhibitor shall not, without prior written consent of Trigger Agency, LLC, assign or sublet such space, or any part thereof, or move out his display before official closing of said show.
